#### **ELECTION OF OFFICERS**

At its January meeting, the Commission elected its officers for 2017: Harvey Gersin of West Bloomfield as Chairperson, Matthew Benavides of Sylvan Lake as Vice-Chairperson, Anne Dziuba of Orchard Lake as Secretary, and Michael Grogan of Keego Harbor as Treasurer.

## SUNSHINE WEEK

At its January meeting, the Commission adopted a "Resolution in Support of Sunshine Week 2017", including a recommendation that the four communities support open and transparent government.

## STRATEGIC PLANNING INITIATIVE

At its meetings in the first half of the year, the Commission received committee reports regarding implementation of Phase 1 (January 1 – June 30, 2017) of its strategic plan.

## FINANCE AND FACILITY REVIEW

At a joint meeting in March with its Finance Committee, the Commission reviewed 2016 revenue and expenditures and discussed the outlook for future revenue considering AT&T's move away from cable to satellite service and decreases in cable subscribership generally.

At its April joint meeting, the Commission and its Finance Committee discussed 2017 revenue projections and reviewed draft budgets for 2018 and 2019.

At a joint meeting in December, the Commission and its Finance Committee reviewed 2017 revenue and expenditures and toured the Green Media Center facility, focusing on current equipment and additional and replacement equipment which will be needed over the next year or two.

#### CABLE INFRASTRUCTURE IMPROVEMENTS

At its April meeting, the Commission received a report regarding the upgrade of cable technology at West Bloomfield Town Hall, Keego Harbor City Hall, and the Sylvan Lake Community Center.
